WHAT TO BRING:

- A valid photo ID for you and your spouse (if married filing jointly). For married filing jointly, both spouses must be present.
- Social Security cards or ITIN notices/cards for **all individuals** on tax return
- Birthdates for **all individuals** on tax return
- All Forms W-2, 1099, and information for any other income
- Information for all deductions and credits
- Form 1095-A, B or C (ACA statements) from insurer
- Total paid to child care provider and their tax ID number
- Copy of prior year tax return
- Proof of account for refund direct deposit or proof of account for electronic funds withdrawal

All sites listed offer **FREE** tax prep **and** electronic filing for basic returns.

SITES WILL NOT PREPARE:

- Schedule C with losses
 - Complicated Schedule D
 - Schedules E or F
 - Forms SS-5 and SS-8
 - Parts 4 & 5 of Form 8962
 - Any income tax returns beyond the volunteer's certification
- Please see a professional preparer for assistance with complicated returns.*
